

## Lakeland Trails Virtual Ultra Competition Terms and Conditions

1. The promoter is: Lakeland Trails Ltd (company no. 09875574) whose registered office is at 27 Oaktree Crescent, Cockermouth CA13 9HR.
2. The competition is open to residents of the United Kingdom aged 18 years or over except employees of Lakeland Trails and their close relatives and anyone otherwise connected with the organisation or judging of the competition.
3. There is no entry fee to enter this competition other than that of the event entry fee.
4. By entering and participating in the competitions, an entrant is indicating his/her agreement to be bound by these terms and conditions.

6. Final Closing date for entry will be Sunday 20<sup>th</sup> December 2020. After this date the no further entries to the competitions will be permitted.
